

## Forensic Flashback

### A Murderous Vice President

It's been quite a month for Vice Presidential history, but nothing like what happened 220 years ago. That's how long it's been since Vice President Burr fatally shot Alexander Hamilton on July 11, 1804.

I didn't see the musical but I'm pretty sure it didn't include the inquest that took place the day after Hamilton's death. Here's some information from the official record of the inquest:

"John Burger Coroner for the Said City and County of Newyork," convened an [inquest](#) jury on July 13, 1804. Fourteen "good and lawful men" (yes, only men) were selected for the jury that was charged with determining "When Where how and by What means the said, Alexander Hamilton, Came to his death."

The jurors found that not only Burr but two co-conspirators "feloniously Wilfully and of their Malice Aforethought, did kill and Murder (Alexander Hamilton)."

Final note: Coroner Burger charged the City of New York \$5.25 for his services in the Hamilton case.
